How can I give?

At Christ Church we rely on the servant heartedness of our volunteers to keep going.

We need our members to give their time to serve, whether that is volunteering with the children and youth, on the service rotas or in other ways.

We ask that you give yourself in prayer, that you pray for the ministry of the Church and its growth spiritually.

In order to keep up the ministries that we are running we also need our members to give to the work of the Church financially.

Your giving enables us to continue outreach work, to continue to serve the young people in our community bringing them to Christ and enables us to employ the staff that are needed to facilitate these vital ministries. Of our income we also give at least 10% of what we receive to different Christian charities throughout the year through our alms. At Christ Church we encourage our members to give in a planned and proportionate way, this can be done by standing order direct from your bank, through our monthly giving envelopes or by bank transfer.
